NOTE: *The applicant is requesting that this item be continued to a future date to be determined pending completion of the analysis requested by the City Council for the pending use permit appeal related to this proposed facility.*

Public hearing to consider approval for the construction of a new 35-foot tall artificial pine tree (monopine) which is proposed to have twelve panel antennas (75" tall x 10" wide x 5.5" deep). Initially, four equipment cabinets (6' 6" tall) are proposed to be located within a lease area approximately 20' wide by 30' deep. The equipment cabinets would be screened by a 6' tall chain link fence with vinyl slats. Two additional cabinets are proposed, for a total of six, but would be installed at a future date. In addition, the Commission is requested to accept the categorical exemption (Class 3) proposed for the project pursuant to Section 15303 of the Guidelines for the Implementation of the California Environmental Quality Act (CEQA) of 1970, as amended, which consists of construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made to the exterior of the structure.
