Public hearing to consider approval of a request for a Minor Use Permit to allow an outdoor display for two propane exchange racks (per Section 18.25.100). The exchange racks would be displayed against the front wall of Safeway approximately 20 feet south of the southernmost entrance. In addition, the Zoning Administrator is requested to accept the Exemption pursuant to Section 15311 of the Guidelines for the Implementation of the California Environmental Quality Act (CEQA) of 1970, as amended, as a Class 11 categorical exemption - -accessory structures, because the project consists a small outdoor display area that is mobile (not permanently affixed to the ground).
